



Terms & Conditions

DRIVING AND DELIVERY:

Goods are originally transported on Euro pallets, unless otherwise agreed, otherwise special prices must be charged.

If travel is ordered on a different vehicle type than the one offered, the invoicing price will be changed.

Unless otherwise agreed, invoicing is based on the consignment note, delivery note or received electronic data.

Acknowledged waybill or photo documentation is valid delivery documentation.

It is always the customer's responsibility to ensure free access and correct transport and address information so that collection/delivery is possible. If this is not met, additional costs must be incurred.

IN GENERAL:

The journey will take place with carts and semi-trailers, unless otherwise specified.

It is a prerequisite for driving, according to the submitted offer and regardless of the agreed start time for the task, that Thortrans Randers A/S can get the customer credit approved and that the customer has no overdue items on his account with Thortrans Randers A/S. Otherwise, Thortrans Randers A/S is entitled to refrain from carrying out the journey in accordance with the submitted offer, and the customer cannot assert a claim in this connection.

Prices are excl. Diesel oil surcharge, taxes and VAT.

Expenses for the bridge, ferry, tolls and tolls are settled separately, unless otherwise agreed.

Diesel fuel surcharges are regulated on the basis of ITD's cost index.

The prices are daily prices, with the usual reservations for price increases due to the oil situation and tax regulations as well as other political/economic interventions that we are currently not aware of.

The prices are based on driving in the time period at 7:00 a.m. – 3:00 p.m.

Max. loading/unloading time is 15 minutes for carts/semi-trailers and 15 minutes for solo cars, then the waiting time is calculated. For a total waiting time of more than 180 minutes, the whole day is calculated on hourly wages and any expenses.

Reservations are made for price and tax increases coming from outside.

When driving outside Denmark, extra costs for special transport documents and customs clearance must be assumed.

In connection with Thortrans Randers A/S's submission of an offer, where the buyer sends tender material with a description of the task, the buyer must mark the parts of the tender material that are important for Thortrans Randers A/S's submission of the offer.

any other tender material will not be reviewed prior to the submission of the offer, and is thus not valid between the parties.

In the case of hourly driving with an outlay, the invoice is always for a minimum of 1 hour.

REKLAMATIONER:

- Modtager må straks ved modtagelsen sikre sig at leverede varer er mangel fri og i øvrigt overholder de stillede krav.
- Eventuelle reklamationer over synlige skader, mangler og/eller mængder, skal skriftligt fremsættes omgående.
- Eventuelle reklamationer over ikke synlige skader, fremsættes skriftligt senest 7 dage efter leveringsdagen. Reklamationer senere godkendes ikke.
- Reklamationer behandles iht. nedenstående punkt ang. Ansvarsforhold.

BETALINGSBETINGELSER, MORARENTER OG REGULERING:

- Såfremt andet ikke er aftalt, forfalder det ud fakturerede beløb til øjeblikkelig betaling (Netto kontant).
- Reklamationer til faktura, skal fremsendes skriftligt senest 7 dage efter fakturamodtagelse.

ANSVARS FORHOLD

- Alle opgaver udføres i henhold til Nordisk Speditørforbunds Almindelige Bestemmelser (NSAB 2000). Bestemmelserne begrænser vort ansvar for bortkomst, forringelse eller beskadigelse af gods til SDR 8,33 pr. kg og for forsinkelse op til fragtbeløbet, maksimalt SDR 50.000 for hver ordre. Ved oplagring er speditørens samlede ansvar for skade ved en og samme hændelse begrænset til SDR 500.000 (§ 27). Særlig opmærksomhed henledes på, at krav mod speditøren forældes efter 1 år (§ 30), og at panteretten (§ 14) omfatter såvel aktuelle som tidligere krav. Krav på fragt m.v. skal honoreres uanset handelsaftalens leveringsbetingelser (§ 10).
